Parents:

- The goal of the **3 Steps to a Great Kid™ After School Karate Program** is to provide a safe, secure and stimulating environment for youth, Monday through Friday, during the after-school hours based on the Martial Arts character development program **3 Steps to a Great Kid™**. The program will enrich the lives of the youth through their participation in structured activities that provide recreational, cultural, social, and life skill experiences, in the context of training in the martial arts.
- In order to enroll in the program you and your child must complete an enrollment packet. **All Enrollment Forms Must Be Filled Out Completely!** Only students who submit completed forms will be accepted into the program. All incomplete forms will be returned and those students will not be accepted until completed forms are returned.
- If your child misses three days through out the After School year without an excused absence, or if they are picked up before 5:15p.m. more than three times. Then the **three-strike rule will apply and your child will be removed from the program.** This program is designed for participants that will utilize the opportunity to its fullest.
- Spaces are limited - **Please Return Completed Forms As Soon As Possible** to assure your child's enrollment.
- There will be **Vacation Karate Kamp** packages available at an additional charge, which will cover **Early Release Days or Non-school days, with the exception of federal holidays.**

The 3 Steps to a Great Kid™ After School Karate Program is not a licensed child care program. The program is not regulated or licensed by the Texas Department of Human Services.

We are concerned about the safety and well being of your child. We encourage you to talk with your child about his/her need to adhere to all areas of the student rules contract. Please understand that failure to follow the conditions of the student contract may result in suspension or dismissal from the program.

If you have any concerns, please feel free to talk with any of the instructors of the **3 Steps to a Great Kid™ After School Karate Program**. We encourage you to volunteer your time to teach special programs, coach sports, help with cultural development projects, or mentor with the program.

Glossary of Terms

After-School Program - A group of supervised and structured leisure activities that take place from 3 p.m. - 6 p.m. The participant is required to register, sign-in and is expected to remain for the full length of the program day. After-school programs must comply with Youth Standards of Care.

City Youth Standards of Care - Chapter 12 of the Dallas City Code, Ordinance Number 23159. The implementation of the standards in this ordinance allow City youth programs compliance with Section 42.041(b)(14) of the Texas Human Resources Code, in order to exempt those programs from state child care licensing requirements.

Daycare - Relating to, or providing supervision and facilities for children during the day and which is licensed by the State. The 3 Steps to a Great Kid™ Karate After school program is not daycare.

Karate After School Program Director - Employee of Chamberlain Studios of Self Defense™ whose role is to supervise the Karate After School Program.

3 Steps to a Great Kid™ - The Martial Arts character development program developed and copy written by Dr. Nick Chamberlain, and utilized by Chamberlain Studios of Self Defense™ as the guiding philosophy in it's After School Karate Program.
